Questionnaires and supporting documentation will be accepted up to the 30th calendar day of the quarter. If all documentation required to make a decision has not been submitted by the 30th calendar day, that request will be considered for the following quarter.

Tacoma Community College students who are classified as non-residents (out-of-state) at the time of their admission may be eligible to establish residency, for tuition and fee purposes. Students must be able to document their intent to establish Washington as their permanent domicile (residence) at least twelve months prior to the start of the quarter for which they are applying. If non-resident tuition was paid, and the request has been approved, the difference in tuition may be refunded.
