6. OTHER Committee Business

a. Online Course Proposal Form – Barbara Peterson

Barbara asked for input from the committee regarding changes to the course proposal form. The process is moving forward to put this form online.

b. Curriculum Alignment Project – Kim Rzeszewicz

Kim distributed a handout of data to the committee. This project will include looking at the sequencing of courses as well. The accreditation committee will address the issue of curriculum in 2014. Another taxonomy can be used, but Bloom's Revised Taxonomy is well-known, widely used, and simple. Smaller programs that have only 1-2 faculty are concerned with the magnitude of this project as they have no ability to spread the workload. Kim said this has been addressed.

c. AAS Degree Completion Petition

Ryan David Watson – Motion was made by Rosalie Robinson to accept this petition from Ryan David Watson for Associate in Arts & Sciences degree completion in winter of 2010, and Susan Schneider seconded the motion. **Motion carried with two abstentions: Robert Hijiya and Bernie Comeau.**

<u>Elaina M. Trammell</u> – Motion was made by Greg Ferencko to accept this petition from Elaina M. Trammell for Associate of Arts & Sciences degree completion in winter of 2010, and was seconded by Rebecca Sliger. <u>Motion carried without no abstentions.</u>

- d. Pre-Nursing Degree Update Julie Benson discussed allowing higher-level biology classes that incoming students take count toward BIOL-160 as it makes no sense to require these students to take a lower-level biology course when they have successfully completed the higher-level course.
- e. MATH-095/MATH-097/MATH-099 Tim Stokes recommended that Jamie Palermo go through the coursebank to determine what other courses are affected by the MATH course changes, in order to make the changes all at once across the board. The list will be distributed to the appropriate departments for approval before submitting to the committee for approval, with the Math department overseeing the process. Motion was made by Rosalie Robinson to approve this course of action, and was seconded by Rebecca Sliger. <u>Motion unanimously carried.</u>
