NUTR 101& Human Nutrition

- a. *Phil Hunter* moved to approve the updates to this courses.

- c. Discussion Points:
- -Phil explained the purpose of the changes to the prerequisites and outcomes.
- -Tim asked if Mike Flodin had been contacted to have discussion about the VPs underlying concerns about enrollment dropping.
- -Phil: No discussion with Mike F. There is no change in the math prerequisite. Rate at which students pass will increase with change in prerequisites.
- -Tim's concern is that 1/3 currently enrolled students who do not meet the proposed prerequisites would not be able to access the course. Math prerequisites will make course inaccessible to many students.
- --Sharon: polled 7 sections, most of the students who do poorly are not allied health students; by letting them in, we invite them to fail, because they don't understand that Nutrition is a science-heavy course.
- -Barb: Perhaps we need two courses: an entry-level Nutrition course, and a 200-level Nutrition course for allied health students.
- -Tim stated he will not approve this course unless another course is created to provide more access, or Bio 100 math prerequisites are lowered to Math 85. Requiring Math 90 will not allow as many students to take the course. Suggests alternately that a nursing-specific course be created.
- -Tim suggests the science department create a second course.
- -Ruth Ann: Science department may not want another entry level lab course, would allow students to take distribution of lab courses exclusively in bio sciences without getting a breadth of exposure to other sciences.
- -Char: can we even change this to 200-level since it is CCN?
- -Julie: also this course is required for transfer degree, so there is a state-level consideration.
- -Tim: can create a higher level course for allied health.
- -Phil: Once a proposal comes to committee we must approve/reject/table. To move forward, we must approve or reject.
