Discussion: Pat von Knorring explained these are not new courses, just a rearrangement of MT II. All 5 of these equal HIM 131. Some students (ESL and Ibest, in particular), have a hard time doing all five modules in one quarter. In 1-credit modules, could offer 2 courses in Fall, and 3 courses in Winter. Also, some programs don't require MT II, but those students in those programs might still benefit from taking a couple of modules. Other students will benefit who don't want to carry a full 15-credit load.

Char: how do we change it in the system to indicate that prereqs can be EITHER HIM 131, or HIM 135-139.

Kim: will have to investigate how Curricunet could make those changes.

Char: will be problematic for Spring qtr if this isn't in the system yet; students taking the series might not be "approved" to move on

Colleen: can build into degree audit.

Kim: how many programs require MT II?

Just HIM and Pat's program.

Char and Pat agree that either way of completing MT II will work for their programs.

Kim: Is it OK to leave the prefix as HIM?

Pat: Yes.

Phil: prereq is HIM 130 with C- or better.

Char & Pat: should be C or better. Kim will change.

Char: all classes in the HIM program must be passed with a C, or student can not progress.

Phil: Is this model scaleable? Will it be problematic if others want to do this?
