### Motion: R. Robinson

#### Second: P. Hunter

**Discussion:** Jackie: Math dept looking for a way to get students through the 4 dev ed math courses more successfully. Created 5 credit classes that are more flexible – can move through more quickly, or slowly if they need more than one quarter.

Kim : Can take it twice – so, for students who are taking it slower, is it just 5 credits even if they spread over two quarters?

Jackie: Can't do variable credits; besides, students don't get credits for dev ed math, except in terms of financial aid.

Steve: CMath 85 works for a prereq for Math 90, for example. Have figured out how to let students register for the next quarter, but will flag if they haven't completed by the end of the quarter.

Jackie: students who complete a CMATH course (with an "S" grade) are "listed" as having completed a MATH 75 course in the registrar's system.

Susan: Isn't this a lab, as opposed to a lecture?

Jackie: It's more similar to an online course than a science lab course. Lectures will be available to students online.

Greg: Addendum to CMATH courses are minor; just adding the word "and" in the prereqs, and a period.

**Discussion:** Kim Lee – rationale for breaking out the courses is that under the former HIM 253, which encompassed all three, if a student failed one part of these, they would have to take all 12 credits again.

Char: will likely need to move the quarterly hours around, esp. for the "in the field" credits. 255 is out in the field, supervised by different people. 255 is a mix of worksite and lab. Barb: it's fine to leave 255 as lab.

Kim: Kim will change from variable to 5 credits.

Char: 250 really will be variable, though, 2-5 credits.

Barb & Kim: so, leave 250 as is; change 255 to 5 credits; and 254 can leave alone.

Kim will change action verbs in 250 for objectives 2, 3, and 4.

Phil: are these supposed to be "repeatable?" For extra credit?

Char & Kim: no, that's wrong – Kim R. will change to repeatability of 1.

Phil: Problem for corequisites – if they need to take one again, co-req would mean they have to take the other again, too.

Kim R. will fix the prereqs/coreqs on all of these courses.

#### a. *Curriculum Committee Manual* – BP (Please Review)

Please send suggested updates for this manual or comments to Barb and/or Kim R. Barb: Independent studies 299 has come up again recently. Maybe each dept, if they want a 299, could have a general prereq such as "completion of some basic/general course." Please send feedback to Barb

#### b. Curricunet Update – KR

Email KimR. with any curricunet problems; almost done with the "tweaking" process with vendor. Still some fuzziness between "pending" courses and "Launched." Should the course be frozen – so once approved down the chain, can't be changed again by the originator? Yes was the overwhelming response from CC members -- Kim will freeze.

Curric Comm will also in the future see degrees/certificates that are being modified, deleted, added, etc. in Curricunet.

Syllabus module also not yet available, but will be rolled out soon. Probably most useful to adjunct faculty or first time teachers of courses.

Curricunet has to be accurate and up to date because it will be the source of info in the online schedule in the future.

Phil suggests that the course outcomes be included in the online schedule for students to see. Kim will investigate feasibility

c. *Pending vs Launched* – KR (see notes in section (b), above)

d. *Alternates and PAU credits* BP – curric comm. members get 1 PAU per quarter, so 3 per year. Alternates who attend one meeting per year will get 1 PAU for the year.

e. *Five Year CAP Review Cycle* KR (Please Review)

Kim identified 18 disciplines that CAPped the majority of courses last year. Need 18 to do it

every year. Have identified 18 more disciplines to finish CAP this year.

#### f. Credit Hours/Credit Calculations BP (Please Review)

Barb: last updated as a WAC in 2010. Our formula is 11:1 (based on 11-week quarters). Char: Curricunet wording does not match WAC wording. Kim R. will fix Curricunet.
