Wendy: Is the same course, but this one is for the students who can't enroll in that class because they placed in ABE.

Phil: so class will be mixed – so they should be cross-listed?

Barb: no – because the ESL and AESL can't cross over, even though they are taught together.

Wendy: strictness has to do with funding sources and how students are "federally reportable".

# b. Associates Of Technical Arts General degree

Kim: a couple of degrees in catalog that not many students use. ATA General degree is intended to be an upside-down degree; student transfers in up to 60 credits from a technical college then finish here. The ATA is NOT a transfer degree. Has been little Interest with only one student in last 5 years has graduated with this degree. None since 2007-08. Probably because technical colleges now can offer Associate degrees that are transferable to four year schools.

Any good thoughts about why we should keep it or discard it?

Barb and Robert: Is not really in the students' best interest to get this degree anyway because it cannot be transferred.

Colleen: If it's deleted, students can still be grandfathered for 5 years if they've started it. C. Gore: *Moved that the Curriculum Committee* 

endorse the deletion of the ATA General degree R. Robinson: Second Motion carried

C. Physics common course numbering

P. Hunter: moved to recommend making administrative changes within Curricunet to change the course prefixes and course numbers on Phys 114, Phys 115, Phys 116, Phys 121, Phys 122, and Phys 123 to the newly changed common course numbers: Phys& 114, Phys&115, Phys&116, Phys& 121, Phys& 122, and Phys& 123 respectively. Second: R. Hijiya

Discussion

Phil: when CCN happened, Phys classes decided to not transfer classes to CCN because felt would be confusing to students.

New series of course numbers just adds &, so transition won't be confusing to students. Rather than resubmit courses for approval, would like to just make this administrative change. Colleen: when would this go into effect?

Phil: Fall quarter.

Greg: You need to tell advisors and all who work with students in planning their education. Phil: Yes, we will inform them.

#### d. Courses to be deleted:

Kim: many courses still in Curricunet and the college catalog floating around; Kim trying to get people to delete any course that they know 100% they will not teach again. Will be asking curriculum committee members for assistance; would like it to be cleaned up before the catalog comes out. Hopefully these can be cleaned out by spring. If a course is deleted, it is listed in the Curricunet archives and can easily be retrieved if one wants to teach the course in the future.

All people have to do is copy the course, then complete the cover page. 5 minutes.

#### e. Coordination of many entry points to one in Curricunet

Kim: there is a database where stuff gets entered manually, and some info gets pulled from SMS; that is how the online schedule and catalog get populated. Not currently connected to Curricunet, but there is a movement underway to have that info pulled from Curricunet to have uniform information across the college. In the future, students will be able to access course outcomes from on-line scheduling as well as the course objectives.
