SCI 105 Introductory Topics in Natural Science

Second: Phil Hunter

Discussion: Heather Cushman explained this course will provide a new lab class and is intended to get students interested in science generally. Lower math pre-req. Multiple-science-disciplinary. Theme can change quarter-to-quarter. Math090 is now a co-req vs. a pre-req.

Bernie: Any transfer issues investigated? Soc sci course similar to this one had issues because it wasn't going to transfer well.

Heather: might not transfer as a specific class, but would transfer as part of the degree.

Bernie: maybe add that to the course description

Phil – Transfer issue probably not a big deal to science students; several other science courses offered here only transfer between comm. colleges. This course would transfer the same way as those other courses.

Julie : So this course would meet the Transfer A/Nat'l Science distribution requirement.

Greg: And taking this and, for example, Bio would meet the two requirements in Science.

Phil: yes.

Discussion: Shea Bower explained the rationale for these second quarter program updates. She also included an updated flow chart of what is taken what quarter. The skills do not build on each other, so sequencing is not an issue. Sequencing is important in

clinical.

Regarding repeatability: should be “repeatability 1”. Kim R will fix.

Kim R: Will include minimum grade of C for 101 for the prereqs for 102; matches the grade requirements used in the Nursing courses.

Shea: for 175, decided to eliminate the cross-listing with RC and RT discussed at the last meeting; this course is too different to be cross-listed. Yes, it should be published in the catalog.

Kim R: no prereqs for 121?

Shea: went back in and revised --- now fixed.

Phil: all meet QSR?

Shea – Curricunet required her to pick a “domain”. QSR is incorrect -- Kim will fix.

7. DEGREE/CERTIFICATE Courses

CC will start reviewing degrees and certificates. We will run three program degree/certificate from committee members to work out the procedural issues before this moves forward for other groups to review in the future

Char – national association changed competencies; needed to make updates on that account. Also, the HIM program is re-merging with MO program, which formerly had 1-year certificates that HIM is integrating into their program. The first year of HIM is now those two 1-year certificates.

First year is lock-step (see the chart Char distributed in the meeting).

The two certificate paths (Medical Reimbursement Specialist and Certified Physician Practice Manager) involve taking the same courses through the 3rd quarter; at that point students decide how they want to specialize, and choose one certificate path.

Students can stop if they like after one year and sit for their specialized credential, or go into the second year of the HIM program.

Certificate program will start in spring 2013.

Kim R: Will this work for publication in the catalog?

Carroll F: Yes.

The 2-year degree is pretty much the same as it has been; had to add a few classes to accommodate new requirements passed down from the national association.

Barb – going forward, Curriculum Committee will be involved in degree/certificate endorsement.

Char: 105 – Really is 5 credits. ONLY for HIM students; the 131 still exists for non-HIM students -- that is still 8 credits.

Char noticed anyone who scored lower than B in biology has a hard time in HIM program; for that reason, wants to keep prereqs at no lower than C.

150 and 222 – used to have these courses a long time ago, now bringing them back. These numbers are shared with Shoreline. That's why they appear to be not "aligned."

185, 86, 87 – only difference in course descriptions for these is the "specialization."

Kim R: 150 CLO 13: change "and so on" . . . going to remove.

Char – also, the "weird letters" next to the PLOs in some CLOs are related to the national association.

Kim R: 152 Course description: will change to "Course includes extensive advanced practice"

8. OTHER BUSINESS

a. M designation draft

Phil explained no changes were made in terms of what an M course is. But old document was confusing, so created new document describing requirements for M in more detail was created by Phil, Greg, and Bernie. Need some re-tweaking of the associated Curricunet screen, but would like this document to be easily found by faculty in multiple places (e.g., in Curricunet, in portal, etc.)

Mike Flodin made the committee aware that there have been some issues around the M designation on the state level; in the last year, the state system decided there would be mandatory reciprocity of M across WA community colleges. A few colleges, like TCC, have 50+ M courses. Most colleges have about 10 or even fewer. This is no problem for TCC, but other schools have very strict guidelines for how their students meet the M or “diversity” requirement.

Char Gore moved to endorse M designation guide for inclusion in the Curriculum Committee Handbook.

b. Degree/certificate reviews - Kim R and Barb will be meeting with Tim in January to establish a college wide review flow chart. Curriculum Committee will review it at the February meeting.

c. ALP – Accelerated Learning Program

Kim Ward presented information on ALP which is part of an effort to streamline students through dev ed. Many students testing into dev ed don't really need the whole sequence -- just a brush-up. With instructor recommendation, students can by-

pass 95 and go straight to 101 as long as they take a “companion course” (in this way, it’s similar to the I-BEST program). So far, results have been very encouraging.
