**John Falskow** explained that all the classes in this list needed to have their outcomes aligned with the Humanities Division PLO's, but more issues have revealed themselves during the CAP process; they need to reorganize and do a complete audit of the division's SMS titles and course numbering that has been done from 1965 until now. They have identified and are willing to fix the problems, but it will be a massive undertaking that will require time to be done right. **John Falskow** noted that they need to make sure the documentation reflects the

good teaching they've been doing.

David Endicott said the Humanities division has shifted

so much in its curriculum process that it will take more time to clean it up—possibly to the end of this academic year.

Barb Peterson and Kim Rzeszewicz then suggested a plan: They will

work with the Humanities Division to develop PLO's and course outcomes, and if any of these courses are to be offered in the fall, Barb will give them provisional approval now and then bring them to Curriculum Committee in the fall.

Kim R. mentioned that she would work with the division

as an outside facilitator to keep the process moving smoothly. She sees this as a vignette for our

self study: how we've identified a problem and sought ways to fix it. There are bigger questions that surfaced that need to be answered too, including how to redesign the Humanities PLO's and develop a curriculum flowchart.

**Tod Treat** noted that John Falskow is carrying the burden of decades of not-sufficient attention in these courses; we can't have strong instruction without a good curriculum—we shouldn't focus on getting forms filled out for CC purposes only. He also noted that non-CAPped courses won't be allowed to be offered, so we need to be careful with provisional approvals.

Also, all these courses must be CAPped by November 2014, and they must be CAPped before being offered; thus, all Fall Quarter classes must be CAPped at the April 7 CC meeting.

**Becky Sproat** suggested that a librarian be included in the discussion on these courses.

**Dave Howard** moved to table these 91 Humanities Division courses, with a second by **Julie Benson**. **Motion carried**.

Allison Muir explained that with the new for-profit GED, the state has opened new options for students, which has necessitated a redesign of the ABE program for students who want to take the GED test or transition to college.

Kim Rzeszewicz asked how this compares with Fresh Start,

Allison explained that Fresh Start is for students under age 21.

**Kim Ward** noted that the State Board didn't give much guidance for this process, so the faculty worked hard to ensure that the rigor and content were there and that these courses were truly meeting High School requirements.

**Kim R.** mentioned that all CC member comments have already been addressed, but there were still some issues with some of these ABE courses: in ABE 067, the prerequisite

should be ABE 066 math; also, some of the CLO's need to match. In ABE 068, the prerequisite should be ABE 067 and assessment at or above Math 85.

**Greg Ferencko** asked if these were tied to science classes, and if so, would there be a co-requisite; **Allison** explained that there were no co-requisites; all of the math and science is taught within the ABE course.

Examples of special topics are volcanism and St. Helens floods in central Washington (for Geology). These are non-lab courses.

Kim Rzeszewicz asked if there are ever any issues with

the 15-credit distribution requirement,

Phil explained that there aren't any issues since these

courses can also be used as non-distribution electives. He also noted that BIOL 294 is an experimental research course, so the number of credits (variable—up to 5, with a repeatability of 2) depends on the scope of the projects done in the course.

**Rebecca Sliger** explained that these are both CAP updates. ENGR 114 counts for both Humanities and Engineering, so the outcomes for this course are aligned with the outcomes for both of these divisions. ENGR 114 is no longer a performance skills class though it has a lab component (it is held in a lab classroom) and there are a lot of lab activities.

Barb Peterson suggested that it may be better without a lab definition for now, and then it can be modified in the future,

#### Rebecca agreed.

Kim Rzeszewicz noted that some

wordsmithing was needed on the 299 course to make sure the verbs were measurable. After some discussion of the wording,

**Rebecca** suggested that she and Phil Hunter could work something out and bring it back to CC later since this course won't be taught until Winter 2015. Accordingly, **Phil Hunter** amended his motion to ENGR 114 only, with ENGR 299 tabled, and **Dave Howard** seconded. **Motion carried**.

For now, a printed copy will be supplied to each faculty building rather than having a copy printed for every person. A few minor edits were made in the latest version of the Manual,

**Kim Rzeszewicz** noted that the Writing Intensive guidelines still need to be revisited; this will be put on a future CC agenda.
