**Motion:** Char Gore. **Second:** Darlene Rompogren. Darlene explained that EAP 97 is being updated to correct an earlier error in the number of credits (should be 10, not 8); EAP 92 is being updated to add the newly updated EAP 95 as a prerequisite; and EAP 95 is being updated to increase the number of credits from 10 to 14 to allow for the material from the deleted EAP 91 being added to the course. **Motion carried.**

**Motion:** Char Gore. **Second:** Mike Mixdorf. Barb explained that these updates are mostly prerequisite changes. The first eleven of these courses are second-year specialty courses. Tracking these for the past three years, HSP faculty have seen that students who have not taken the first-year courses before attempting these do not do well, so the first-year courses are being added as prerequisites to the second-year courses. For the last three courses in this list, the only change is the class cap (maximum number of students). Kim R. wondered what will happen if students can't register for these because of the new prerequisite, and Barb explained that the information about the prerequisite change would be explained to the students during advising sessions the first week of February. Tod Treat further explained that current students have the option of using either the current (new) catalog or the previous catalog and thus can avoid being affected by any prerequisite changes that are made. **Motion carried.**

#### 9. OTHER BUSINESS

# a. FEPPS - ENGL 103; SPAN 121; PSYCH& 100; MATH&107

Sherry Cmiel moved to recommend transcription for these courses, with John Falskow seconding the motion. These courses, which are currently being offered, have gone to the chairs of their respective programs or departments, and all questions have been addressed. **Motion carried.** 

## b. Re-organization of CC reps – position 10

This is an informational item only. Due to the reorganization of Transitional Studies, there will no longer be separate positions for ABE and Transitional Studies; Darlene Rompogren now represents the new C&TS (Communication and Transitional Studies) division. Barb will send out a new organizational chart to all CC members.

#### c. Committee Reviews

Barb explained that we need input on what really needs to come before the Curriculum Committee, that is, what we need or don't need to look at (class caps are one example). John Falskow suggested that small changes such as class caps could be done by report rather than having to go through Curricunet and then CC. Barb agreed, saying that we could take care of some of these non-substantive changes administratively and then list them as a notification item on the CC agenda. Tod Treat added that this is about making CC discussions of courses more appropriately about program-level ideas rather than about minor edits. Phil Hunter suggested that courses that are being CAPped (with minor changes) don't need to be discussed one at a time, and prerequisite or outcomes changes could go through Curricunet but may also not need to be discussed individually at CC meetings. Tod added that discussions of fair and moderate extensions should stay within the department, with only the more substantive changes coming through CC. Barb will email a list of discussion points prior to the March CC meeting; Tod will coordinate with her on the

discussion topics as well.

# d. FYI Administrative changes to SMG courses

These are the Invista courses on Supervision & Management; this is just a minor fix—the number of credits should be three, not five.

# e. Discussion on Competency Based Curriculum

Faculty members have been exploring ways to improve our course offerings. One trend is competency-based courses. Barb asked if this is something we should look at further. Char Gore explained that in this type of course, the seat time is different; rather than basing credits on seat time (such as a set ten-week period), once a student has met the competency requirement, the credit is granted, regardless of the amount of time taken to master the skill. Tod further explained that this better integrates assessment (CMATH is a good example of how this works). Steve Ashpole noted that some schools are 100% competency-based, but we can't live in both worlds; it would be too complicated. Greg Ferencko added that some courses are more amenable to this, such as CMATH, and some aren't. Tod commented that the "messy middle" (between both worlds) is the most meaningful and has the most potential. John Falsko, noting that competencies seem similar to outcomes, wondered what the difference between them is. Barb asked the committee if we should continue this discussion at a future meeting, and John F. suggested that we all go back and talk to our respective departments about this and then continue the discussion at a future CC meeting.
