There is no specific order that they have to be taken in because the pre-requisite for all of them is the RHIT credential. In order to sit for the RHIT credential students have to complete similar educational programs to include an Associate of Applied Science from a CAHIIM accredited institution. The outcomes for these HIM courses are directly tied to the HIM Program governing body's (AHIMA) bachelor level competencies. From here on, all courses prefixed HIT for Associate's-level courses and HIM for Bachelor's-level courses. Students have to apply and be admitted to the program before they can take these courses. **Motion carried.**

Motion: Mike Mixdorf. **Second:** Wendy Fordham. This is the second of five SMG courses being done as part of the 5-year review process for the Leadership Development Program. SMG 101 is the foundation course for the program; it was changed from 3 to 5 credits. **Motion carried.**

9. DEGREES and/or CERTIFICATES

NEW - Bachelor of Applied Science in Health Information Management

Motion: Phil Hunter. **Second:** Wendy Fordham. Char Gore explained that this is the Bachelor of Applied Science degree in HIM. Entry into the HIM BAS will be open only to Registered Health Information Technician (RHIT) certificate holders who have also taken a statistics course. Students will generally enter into the degree in the Fall and follow a suggested path to completion, however courses can actually be completed in any order because the baseline information for all courses comes from the education received in the Associate Degree Program required to sit for the RHIT credential. In addition to the HIM prefix courses, students will need to complete an additional 5 credits of Communication in ENGL 301 Professional Writing and Communication in Healthcare, 10 credits of humanities, 5 of those credits at the 100-200 level and 5 credits in PHIL 401 Biomedical ethics, 10 credits of Social Science, 5 of those credits at the 100-200 level and 5 credits in PSYCH 301 Fundamentals of Research for Healthcare, and 15 additional credits at the 100-200 level from the approved distribution list. Members were provided with the suggested order for curriculum as well as course outcomes for curriculum. As this program will also seek CAHIIM accreditation, all courses for this degree were created to meet the requirements of the bachelor level competencies for the AHIMA. Motion carried.

NEW - Medical Scribe

Motion: Tracey Brooks. **Second:** Craig Cowden. This certificate uses classes that are already being taught at TCC. Motion carried.

10. Program Course Review for Content (5 year review-for information only-no action needed)

Barb Peterson noted that these programs, along with EAP, have completed their 5-year reviews, so no further review is needed on any of the classes in these programs.

11. Other Business

A. FEPPS –ENGL&101, LS10, MATH&107, BIOL&100, HUM285, ENGL&220, PE100 The Freedom Education Project of Puget Sound is a non-profit that wants to offer the above listed courses to be taken by women incarcerated at WCCW. The courses will be taught by qualified faculty from local colleges: Alison Stromdahl and Jim Liner for ENGL&101, Lizz Zitron for LS 101, Matthew Junge for MATH& 107, Rebecca Harris and Leonard Jones for BIOL& 100, Stuart Smithers and Nadya Zimmerman for HUM 285, Devon Hodges for ENGL& 220, and Debbie Leavel and Cari Collins for PE 100. All of the syllabi for these courses have been approved by the appropriate deans and/or chairs, and the courses will be taught beginning in Winter Quarter 2016. Motion to recommend for transcription: Sherry Cmiel. Second: Char Gore. Motion carried.

B. IASC joint meeting - Barb

There will be a joint meeting of the Curriculum Committee and the Instructional Assessment Steering Committee on Jan. 25, 2016. The purpose of the meeting is to discuss how CC and IASC can work together in the future. At the conclusion of the joint meeting, the CC members will stay for an extra thirty minutes to make decisions about the Course Proposal checklist, which Barb will send out to the CC members for review before the meeting.

C. Proposal checklist – Barb

This document shows the approval criteria for a course coming before the CC. The CC members should review the draft of the checklist for discussion at the February meeting. Barb will email the draft to the CC members before the next meeting.

D. Future review process for proposals – Barb and Kim

The new draft of the Course Proposal approval processes shows two new options for courses with minor or no changes being made to them, the idea being that such courses will not need to go through the full approval process but will instead go through a shorter, less involved process. Barb will email the draft out to the CC members in January.
