Motion: Phil Hunter. **Second:** Dave Howard. This update changes the prerequisite minimum grade for these courses from D to C, making it consistent with Biology and Math minimum grades. **Motion carried.**

ENGL/ 085 Academic Reading and Writing I: Foundations ENGL/ 095 Academic Reading and Writing II: Threshold

Motion: Char Gore. **Second:** Sherry Cmiel. This update changes all ENGL/ 85 and 95 courses to ten credits (deleting the 8-credit option for these courses). **Motion carried.**

HUM 110 Introduction to Pacific Rim Cultures (with M designation) HUM 285 The City

Motion: John Falskow. **Second:** Craig Cowden. The decision was made to keep these two courses instead of deleting them, so their outcomes have been updated. When Kim Rzeszewicz questioned the word "appropriate" in the outcome "Develop an appropriate sensibility…", John Falskow said that the outcome should remain as written. For HUM 285, the repeatability should be 1, not 2, despite the fact that the subject matter changes; this is to avoid raising issues with transferability. John Falskow agreed to this change. **Motion carried.**

MUSC& 141 Music Theory I MUSC& 142 Music Theory II MUSC& 143 Music Theory III

Motion: John Falskow. **Second:** Jeff Calkins. The outcomes for these courses have been updated for the Associate of Music degree. **Motion carried.**

NUTR 101 Human Nutrition

Motion: Phil Hunter. **Second:** Char Gore. This update was to add a course learning outcome about sustainability so that the course can work with the Sustainability degree. The lack of an ampersand in the title for this course distinguishes it from NUTR& courses, which include a lab component. Tod Treat moved to add the ampersand to this course so that current students won't be hurt by it. Craig Cowden noted that the ampersand is not related to the course description, so the motion was amended to recommend that once Tod and Mike consult on this, if they find that adding the ampersand is in the interest of students, it will be added by the end of this week. **Motion carried.**

Motion: John Falskow. **Second:** Char Gore. These courses have been created for the new Associate of Music degree, to provide two years of one-on-one lessons as the Direct Transfer Agreement for the Associate of Music degree specifies. The repeatability is 3 for each course, so these courses need to be exempted from the Repeat Rule so that the system won't automatically use the highest grade of a retaken class but will instead keep all three grades when a student takes one of these classes three times. The last three courses in this list constitute the second year of Music Theory. **Motion carried.**

Associate in Music (New Associate degree (transfer DTA)

The ensuing discussion revealed that most CC members wanted to be kept in the loop regarding major changes but did not feel that every minor change made by programs needed to come before the Curriculum Committee.

D. Global Learning Task Force recommendations – a vote of endorsement

Motion: Char Gore. **Second:** Sherry Cmiel. Today the CC is just voting on endorsing the shift in focus (the overall recommendations) that the Global Learning Task Force has made, not necessarily on endorsing the actual verbiage in the proposed modification. The Global Learning task force is open to wordsmithing of the document next year. **Motion carried**, with Dave Howard abstaining.
