- I must enroll for required class or classes for my TCC program.
- Adjustments are not processed until I am registered for the credits indicated above and being on the waitlist does not mean I am registered for that class.
- **The Census date is the tenth day of each term (fall, winter, spring). For summer term, it is the eighth day. This is the date that your enrollment status will be determined for financial aid. If you have dropped below the number of credits for which you received aid, you will be required to pay back the difference or possibly all of the financial aid depending on your enrollment level status.**
- **Please wait until your enrollment is finalized and submit one form only. Submission of more than one form causes delays.**
- All grants and institutional aid awards are adjusted based on the number of credits in which you are registered. No adjustments are made to the originated Federal Direct Loan. **Grants** are reduced by 25% for 9 to 11 credit enrollment and 50% for 6 to 8 credit enrollment. For State Need Grant, College Bound Scholarship, and TCC Grant, you must be enrolled for a minimum of 3 credits to receive 25% eligibility of funds.
- I must be enrolled for a minimum of 6 credits to be eligible for Federal Direct Loan and/or Workstudy funds.
- I may be eligible for a reduced Federal PELL Grant depending on my Expected Family Contribution (EFC).
- I must pay my remaining balance if my aid does not cover the full tuition amount.
